The Project consists of two schedules:

Schedule A – PCCP Repairs: 1795 SY 9” PCCP NRDJ removal & replacement; 155 SY 6” AB-2 aggregate base as needed; 20 LF curb & gutter removal and replacement; 4 each inlet protections; 1 Remove/Reset Sign with New Sign Post Footing (PSST); Temporary Traffic Control.

Schedule B – Asphalt Mill & Inlay: 5000 SY milling; 5000 SY 3” HMA-Commercial Grade (Class A); 80 ton HMA-Commercial Grade (Class A)(Patching); Temporary Traffic Control

Bidders may choose to bid either or both schedules. Schedules will be contracted separately unless awarded to the same bidder.
