Bids received after this time will not be accepted.

The Project is generally described as the construction of a drainage channel grading through the City of Lindsborg consisting of the following major items: 6,648 Cu. Yds. Common Excavation, 4.33 Acres Seeding, and 5 Tree Removals with greater than 12” diameter, Culvert Cleaning by Jetting 395 L.F.
