

## NOTICE OF INVITATION FOR BID

The City of Anthony, NM will receive sealed bid proposals on forms prepared by Wilson and Company, Inc., E&A at the City of Anthony Municipal Building located at 820 Highway 478 Anthony, NM 88021, until 10 a.m. (local time) on 1/23/19. Bids received after this time will not be received.

Project consists of pedestrian access roadway and drainage improvements including full roadway reconstruction, new storm drain installation, concrete sidewalk, concrete barrier curb and gutter, concrete drivepad, valley gutter, permanent signing, linear grading and ADA access ramps all located within the City of Anthony, NM.

### **Bidder Requirements:**
